# • Interview of highway applicants

- Neither applicant showed up.

# Highway updates

- o Jacob Kunzman is leaving.
- o Bruce Kupiec will start part-time work again. He is medically cleared to return to work. He needs to contact Michael Hubby.
- Michael Hubby is the contact person for the school.

- Marie requested that all files that members need to view be copied so each member has their own collection.
- Marie requested that all materials relevant to the Select Board meeting be compiled by Friday noon so that members can pick them up and review them with plenty of time before the meeting.
- o Jennifer agreed to implement this organizational plan.

# School committee vacancy

- Stephanie Sayers attended the meeting. She had volunteered to fill the vacancy on the school committee.
- o The School Committee representatives and Stephanie expected that Stephanie would be sworn in and hold the appointment until next year's election.
- o Brenda Smith pointed out that Stephanie's appointment had not followed applicable rules. The vacancy needs to be published 7-10 days before anyone can be chosen to fill the seat.
- o The school committee agreed to publish the vacancy and to finalize the position at the next meeting, on October 24<sup>th</sup>.
- o After the period of publication, the School Committee can recommend their choice to the Select Board who makes the final decision. Val then swears in the candidate.

#### Public comment:

# Dwayne and Stacy Rougeau

- Requested update re: permission to proceed with their building project.
- We need to have a Zoning Board to approve their plan.
- Question raised: Can the attorney proceed with this?
- To give the Select Board the ability to approve this, the town would have to vote to approve giving the Board this authority.
- Select Board will contact attorney to discuss zoning this land.

# o Arleigh Cooper San Zwrba.

- She still has the same issue with the way pipes were laid on her land and the ensuing drainage.
- Gerry said that a plan needed to be drawn up before proceeding.
- Arleigh suggested an engineer should be involved. Gerry wasn't sure an engineer was necessary.
- There is disagreement about whether the town originally laid the pipe or if it was the private landowner.
- Gerry will call the attorney.
- Arleigh also requests that the machine sitting by her property be moved.
- Gerry said the machine will be moved.
- Town will get a plot plan and send it to the lawyer.
- Gerry suggested that the board go visit the property after the meeting.
- Gerry is concerned about the scope of the project and that it involves water and conservation issues.
- Water problems do qualify for ARPA funds.
